- **This is _____ with the Dubois County Emergency Services & RACES Net.** This Net meets every Thursday at 7:15 PM to prepare for the Statewide RACES/AUXCOMM HF net at 7:30 PM and the VHF net at 8:00 PM.
- **The Statewide HF net at 7:30 PM will be conducted by W9SEM** on or about 7.250 MHz LSB. The final frequency will usually be announced on the W9FBZ repeater shortly before the net.
- **The Statewide VHF net at 8:00 PM will be conducted by W9SEM** on the W9FBZ 147.210 MHz repeater at Indianapolis (88.5Hz PL Tone). If we are unable to get in direct on the VHF repeater, we can check in via EchoLink (W9FBZ - node 690934).
- **During the nets, check-ins are taken in the following order** – a roll call may be taken at the beginning of the net. If Dubois County EMA stations are called, please respond. Next is a call for State AUXCOMM team members that have not yet checked in. This this is followed by a call for County EMA's not yet checked in. The Nets are concluded with a call for ANY amateur radio operators to check in.
- **During the nets, all stations are requested to observe the signal strength of W9SEM** and report the received signal quality at the conclusion of the nets.
- **Any stations available to check into the VHF** net direct on 147.210 MHz on behalf of Dubois County EMA call now.
